RULES-REGULATIONS FOR COMPETITORS OF STATE CHAMPIONSHIPS/N.R.A.I. CHAMPIONSHIPS

- 1. Every shooters will have to report to the team manager or authorised person before a day of starting of tournament/ Championships.
- 2. G.S.R.A. Shall not provide arms and admonitions to the competitors.
- 3. Shooters shall heave to collect their competitors card personally before starting the competitions.
- 4. Every competitor is bound to shoot / fire in the detail which is allotted to him / her by the team manager/ authorised person.
- 5. Competitors shall not approach directly to the N.R.A.I. / match organiser without permission of the team manager / authorised person, otherwise strict action will be taken by G.S.R.A.
- 6. Competitors will have to inform about their address of the accommodation to the team manager / authorised person before starting of competition / championship.
- 7. Competitors shall have to present themselves before one hour of starting his/her event at the range where his/her event begins.
- 8. Whenever a meeting is called by the team manager / authorise person every competitor is bound to attend the meeting.
- 9. Every competitor is bound to give co-operation to the team manager / authorised person.
- If Competitor will remain absent in the competition / championship no entry feel will be refunded by the management.
- 11. Weapon control checking is competitor's responsibility. Competitors are advised to contact weapon control officer and get their weapons checked. This is to be done one day before the event stars.
- 12. Any Incorrect information filled in (or not filled), in the entry form by the competitor regarding their previous score or other matter, will be debared for two years for taking part in any competition. Club is also responsible for the recommenced of shooters form.
- 13. Every winner of the event must have attend the prize distribution ceremony, otherwise management will not be responsible for winner's prize.
- 14. Shooter will have to return the unsed ammunitions / empties on completion of his / her match if provided by the N.R.A.I. / G.S.R.A.
- 15. Shooters will have to agree to abide by all the instructions issued by the manager / authorised person from time to time, failling which discilinary action will be taken.
- 16. Medals will not be awarded to those, whose score is less than the qualifying marks as prescribed for the relavent matches irrespective of their individual position. The grading of those securing above the qualifying marks will be done as usual.
- 17. If a shooter will remain absent without prior permission at the prize distribution ceremony, no medal or certificate will be awarded there after.
